- Identify the signs and symptoms of child abuse, SIDS, homicide versus suicide, pediatric fatalities, environmental hazards, and domestic/spousal/elderly abuse and sexual assault in order to appropriately identify cause of death, assist the physician and police in a postmortem investigation
