## COURSE DESCRIPTION

- Define terminology, as related to antemortem and postmortem findings, in order to accurately and appropriately document findings.
- Describe the functions of the medicolegal investigation team. Conduct a medicolegal investigation and effectively complete the paperwork for this process.
- Identify and recognize injuries, describe manners of death, legal issues and toxicology concepts.
- Identify the signs and symptoms of child abuse, pediatric fatalities, environmental hazards, and natural disease, in order to appropriately identify cause of death, assist the medical examiner and police in a forensic investigation.
